The 2016 financial audit will be finalized by the end of October for submission in November along with the current 990. Both will be made available for board review before our next scheduled meeting.

### Revenue:

- DOH grant represents 84%
- Fundraising events represents 10%
- Lower income resulting from loss of 1 time fundraising efforts & supplemental grant

## Expenses:

- \$51,720 paid on 2 grants awarded to Rutgers for \$75,000
- \$2,800 scholarships awarded
- Salaries represented 60%

### Financial Position:

 Cash and marketable securities on hand totaled \$1,124,489 of which \$190,645 is restricted.

#### Resource review:

Tim Omaggio conducted a review of the Board Portal and new Board Portal-Financial both of which are available to board members through the NJCTS website.

Tim also walked board members through the new NJCTS website and it was agreed that the site is attractive and easy to navigate. An updated list of board members and board portal access will be added to the site.

#### Action Items and Upcoming NJCTS events:

- The NJCTS year-end fundraising appeal letter is being prepared for mailing by October 31. Steve Lindenbaum has agreed to tell his story as part of the appeal. Copies of the letter will be sent to all board members for their use in outreach to their networks.
- Conrad volunteered to chair fundraising for the inaugural NJ Walks for TS at Bergen scheduled for November 12, 2016. He will lead the board's fundraising efforts and conduct outreach to the North Jersey business community.
- Steve will reach out to his friend and music celebrity Julian to lend his support to the GreaTS movement
- Amy is in contact with psychiatry and medical education at Cooper Univ Hospital to partner with NJCTS on the Second Annual Childhood Mental Health Symposium to be held in 2017. The First Annual Childhood Mental Health Symposium was held at Rutgers in partnership with NJ Academy of Pediatrics and NJ Psychiatric Association.

- Andrew asked if the NJCTS 990 should be added to the website or just made available upon request. Further discussion will take place regarding this and changing the NJCTS fiscal year to align with the state budget fiscal of July 1 June 30 at the October Executive Committee meeting.
- Andrew will reach out to the Hackensack University Hospital board chair about working more closely with NJCTS to benefit the north Jersey TS community.
- All board members were asked to post a selfie of themselves in a GreaTS t-shirt to #standwiththegreats.org. Developed by NJCTS, the GreaTS is a global platform dedicated to stamping out the stigma of TS. Go to standwiththegreats.org/gallery to see pictures of other supporters wearing their GreaTS tees!
- Through Rebecca's nomination, Faith and NJCTS will be awarded the 29th annual Ann Klein Award for Advocacy by the Community Health Law Project on October 27. All board members are invited to attend.
