NJ Walks for TS was created in 2010 by kids, for kids, in collaboration with NJCTS. The program promotes acceptance, awareness, advocacy, and action on behalf of New Jersey's more than 20,000 children and families living with Tourette Syndrome and its associated disorders—an inherited, misdiagnosed, and misunderstood neurological disorder characterized by involuntary sounds and movements known as tics that affects 1 in 100 children. These 5K walks/family fun runs are a chance to stand up and step out to break the stigma attached to TS and show support for friends, family, and neighbors living with this disorder.

NJ Walks for TS supports the NJCTS Education Outreach Program, providing in-service trainings, Youth Advocate presentations to schools and hospitals across the state, and awarding more than 200 scholarships to New Jersey high school seniors with TS.
